The Mississippi Lottery's Super Santa Promotion

Rules:

- 1. NO PURCHASE REQUIRED: There is no purchase necessary to win, and purchasing Mississippi Lottery products does not increase the chance of winning.
- 2. WHO CAN ENTER: The drawing for the Mississippi Lottery's Secret Santa Promotion is open to anyone 21 years or older who has signed up on the Mississippi Lottery website to be a "Mississippi Lottery Insider." Lottery employees, retailers and vendors, and their immediate family members residing in their household, are not eligible to win any promotional prizes, including the Mississippi Lottery's Secret Santa Promotion.
- 3. DRAWING PROCEDURE: On Tuesday, Nov. 1, 2022, Mississippi Lottery Insiders will receive an email link to an entry form for the Mississippi Lottery's Secret Santa Promotion's first drawing. Subsequent entry forms will be sent each Tuesday throughout the promotion, except for the final drawing, which will be held Dec. 27. Insiders will receive reminder emails periodically throughout the entry period. Completed entries must be submitted by midnight central time before the drawing date.

Each Mississippi Lottery's Secret Santa Promotion drawing will have a unique entry form, and Mississippi Lottery Insiders will be encouraged to submit entries each week. Each entry form will include a list of each prize available for the drawing. Winners from previous drawings are not prohibited from entering subsequent drawings. Each submitted entry is valid for the specific drawing only.

Participants in the drawing for the Mississippi Lottery's Secret Santa Promotion are required to check boxes on the entry form indicating he/she is (1) at least 21 years of age and assumes all risks associated with the prizes, and (2) he/she has read the rules and is not a Mississippi Lottery employee, retailer or vendor, or an immediate family member residing in the household thereof.

Each entry form will include a link to the rules, regulations and prize descriptions associated with the promotion.

- 4. DRAWING METHOD: The Mississippi Lottery's winners for the Mississippi Lottery's Secret Santa Promotion winners will be chosen by random drawing.
- 5. ODDS OF WINNING: The odds of winning the Mississippi Lottery's drawing for the Mississippi Lottery's Secret Santa Promotion drawing are based on the total number of entries.
- 6. PRIZE ALLOCATION: The prizes awarded will be specified in order of the drawing, i.e., the first name drawn will be awarded the 1st Prize, the second name drawn will be awarded the 2nd Prize, and the third name drawn will awarded the 3rd Prize.
- 7. CONTACTING WINNERS: Each winning entrant in the drawing for the Mississippi Lottery's Secret Santa Promotion will be notified by certified mail. Winners have 30 days from the corresponding draw date to respond. If a winner

fails to respond within the time period, an alternate will be selected in the order drawn and notified, until a response is received. The Mississippi Lottery may attempt to notify winner by telephone to alert them of certified mail being sent and to verify address. THE MISSISSIPPI LOTTERY DOES NOT TRANSFER OR SELL THE CONTACT INFORMATION OF MISSISSIPPI LOTTERY INSIDERS.

- 8. PRIZE REDEMPTION: All prize winners will be required to submit proper identification and complete a winner claim form in order to claim a prize the same process used for prize claims for MLC games. Prize winners may download a claim form or be emailed the proper form and submit their claim by mail along with a photocopy of the required identification. The Mississippi Lottery is not responsible for lost or stolen mail. Prizes will be forfeited if not claimed during Mississippi Lottery regular business hours within the specified timeframe.
- 9. WINNERS LIST: The Mississippi Lottery will maintain a list of winners of the Ultimate Secret Santa Promotion and may publicize the winners' hometowns or home counties on the Mississippi Lottery website, via social media or other means.
- 10. NO PRIZE EXCHANGE: All of the Mississippi Lottery's Secret Santa Promotion prizes will be awarded as described. No substitutions.
- 11. TAXES: All federal, state and local taxes on the total prize value, if applicable, are the responsibility of the winner. An IRS Form 1099 will be issued to the winner if required by law.
- 12. DISPUTE RESOLUTION: The venue for any dispute arising under and/or as a result of the Mississippi Lottery's Secret Santa Promotion shall be the appropriate court in Rankin County, Mississippi.
